U.S. Monthly House Price Index Increases 0.7 Percent from September to October

WASHINGTON, DC – U.S. house prices rose **0.7** percent on a seasonally adjusted basis from September to October, according to the Federal Housing Finance Agency's monthly House Price Index. The previously reported 0.7 percent decrease in September was revised downward to a 1.2 percent decrease. For the 12 months ending in October, U.S. prices fell **3.4** percent. The U.S. index is **14.5** percent below its April 2007 peak.

The FHFA monthly index is calculated using purchase prices of houses backing mortgages that have been sold to or guaranteed by Fannie Mae or Freddie Mac. For the nine Census Divisions, seasonally adjusted monthly price changes from September to October ranged from -2.3 percent in the East South Central Division to +2.1 percent in the East North Central Division.

Figure 1: Seasonally Adjusted and Unadjusted Monthly Appreciation Rates





Figure 2: Monthly House Price Index for USA

(Purchase-Only, Seasonally Adjusted Peak was April 2007)




Figure 4: Twelve-Month Price Changes – Prior Year vs. Most Recent Year
